We're pleased to present to you this year's Annual Drinking Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. Our suppliers have a Source Water Protection Plan available for review that provides more information such as potential sources of contamination. I'm pleased to report that our drinking water is safe and meets federal and state requirements. Please help us make this effort worthwhile by protecting our source water. Carefully follow instructions on pesticides and herbicides you use for your lawn, garden and by properly dispose of household chemicals, paints and waste oil. We are committed to ensuring the quality of your water. The water we supply to our customers comes from the Mulberry Fork of the Warrior River, which is purchased from the Jasper Water Works and Sewer Board, and the Eldridge Water System. Eldridge produces their water from two wells which withdraws water from the Pottsville Formation aquifer. Chlorine is added to the water as disinfectant and the required residual is maintained to protect your drinking water from any possible outside contaminants.

Carbon Hill Utilities Board routinely monitors for contaminants in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2021. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk.

### PLAIN LANGUAGE DEFINITION

- *Not Required (NR)* – Laboratory analysis not required due to waiver granted by the Environmental Protection Agency for the State of Alabama.
- *Parts per million (ppm) or Milligrams per liter (mg/l)* - one part per million corresponds to one minute in two years or a single penny in \$10,000.
- *Parts per billion (ppb) or Micrograms per liter* - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.
- *Parts per trillion (ppt) or Nanograms per liter (nanograms/l)* - one part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000.
- *Parts per quadrillion (ppq) or Picograms per liter (picograms/l)* - one part per quadrillion corresponds to one minute in 2,000,000,000 years or one penny in \$10,000,000,000,000.
- *Picocuries per liter (pCi/L)* - picocuries per liter is a measure of the radioactivity in water.
- *Millirems per year (mrem/yr)* - measure of radiation absorbed by the body.
- *Nephelometric Turbidity Unit (NTU)* - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.
- *Variances & Exemptions (V&E)* - State or EPA permission not to meet an MCL or a treatment technique under certain conditions.
- *Action Level – (AL)* the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- *Treatment Technique (TT)* - (mandatory language) A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.
- *Maximum Contaminant Level* - (mandatory language) The "Maximum Allowed" (**MCL**) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- *Maximum Contaminant Level Goal* - (mandatory language) The "Goal" (**MCLG**) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- *Maximum Residual Disinfectant Level Goal or MRDLG* - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- *Maximum Residual Disinfectant Level or MRDL* - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Contaminants that may be present in source water include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- *Inorganic contaminants*, such as salts and metals, which can be naturally-occurring or result from urban storm water run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, storm water run-off, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban storm water run-off, and septic systems.
- *Radioactive contaminants*, which can be naturally occurring or be the result of oil and gas production and mining activities.

Unregulated contaminants are those for which EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted.

The table below lists all of the drinking water contaminants that we detected during the calendar year of this report. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or ADEM requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not change frequently.

CARBON HILL UTILITIES BOARD IS REQUIRED TO MONITOR YOUR DRINKING WATER FOR SPECIFIC CONTAMINANTS ON A REGULAR BASIS. RESULTS OF REGULAR MONITORING ARE AN INDICATOR OF WHETHER OR NOT YOUR DRINKING WATER MEETS HEALTH STANDARDS. DURING JANUARY -MARCH 2021, WE DID NOT MONITOR FOR DISINFECTION BYPRODUCTS (DBP) DURING THE REQUIRED TIME FRAME, AND THEREFORE CANNOT BE SURE OF THE QUALITY OF YOUR DRINKING WATER DURING THAT TIME.

BECAUSE DBPS FROM THESE QUARTERS WILL BE USED IN DETERMINING COMPLIANCE WITH DBP MCLS IN THE QUARTERS-OF APRIL -JUNE 2021, JULY -SEPTEMBER 2021, AND OCTOBER -DECEMBER 2021 CARBON HILL UTILITIES BOARD WILL INCUR MONITORING VIOLATIONS FOR THOSE QUARTERS.

## GENERAL INFORMATION

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

As you can see by the tables, our system had no violations of allowable limits of contaminants in drinking water. We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water IS SAFE at these levels.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and radioactive material, and it can pick up substances resulting from the presence of animals or from human activities.

Some people may be more vulnerable to contaminants in drinking water than the general population. People who are immuno-compromised such as cancer patients undergoing chemotherapy, organ transplant recipients, HIV/AIDS positive or other immune system disorders, some elderly, and infants can be particularly at risk from infections. People at risk should seek advice about drinking water from their health care providers. EPA (Environmental Protection Agency)/CDC (Center of Disease Control) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline. All Drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. Based on a study conducted by ADEM with the approval of the EPA a statewide waiver for the monitoring of asbestos and dioxin was issued. Thus monitoring for these contaminants was not required.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Carbon Hill Utilities Board is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
